**SPECIAL DEPUTY RECEIVER’S AMENDED APPLICATION FOR
APPROVAL OF FIRST REPORT OF CLAIMS**

TO THE HONORABLE JUDGE OF SAID COURT:

CANTILO & BENNETT, L.L.P., solely in its capacity as Special Deputy Receiver of Capson Physicians Insurance Company (the “SDR” and “CPIC,” respectively) files this Amended Application for Approval of First Report of Claims (the “Amended Application”).

I. INTRODUCTION

1.1 The SDR files this Amended Application to obtain approval of its first report of claims settled or determined under TEX. INS. CODE § 443.253. The SDR previously filed its original Application for Approval of First Report of Claims on February 9, 2023. The SDR discovered that the exhibit to the original application contained errors. This Amended Application is filed to correct those errors.

II. AUTHORITY

2.1 CPIC was placed into receivership for rehabilitation in this proceeding on February 11, 2019, and the Texas Commissioner of Insurance was appointed as Receiver of CPIC. The Receiver designated CANTILO & BENNETT, L.L.P. as SDR on that same date. Subsequently, on June 28, 2019, the Court entered its *Order Appointing Liquidator and Permanent Injunction* (the “Permanent Injunction”). The SDR is authorized to file this Amended Application pursuant to

TEX. INS. CODE § 443.258.

2.2 On November 25, 2019, the Receivership Court entered its *Order Granting Special Deputy Receiver's Application for Approval of Claims Filing Deadline, Guidelines for Providing Notice, and Procedures for Processing Claims* (the "POC Order"). The order established December 28, 2020 as the deadline to file POCs.

2.3 This Court has jurisdiction over the subject matter of this Amended Application and the parties herein pursuant to TEX. INS. CODE § 443.005. The Court has exclusive jurisdiction over property of the estate pursuant to TEX. INS. CODE § 443.005(c) and personal jurisdiction over all parties affected herein because this is a civil proceeding arising under and related to a delinquency proceeding under the Texas Insurer Receivership Act, Chapter 443 of the Texas Insurance Code.

2.4 Travis County is the mandatory, sole, and exclusive venue for this proceeding. TEX. INS. CODE § 443.005.

2.5 The subject matter of this Amended Application has been referred to the Special Master appointed in this proceeding in accordance with Paragraph II of the *Supplemental Order of Reference to Master*.

III. FIRST REPORT OF CLAIMS

3.1 TEX. INS. CODE § 443.258 provides that the SDR shall, from time to time, present to the receivership court a report of claims settled or determined by the SDR under TEX. INS. CODE § 443.253. Attached as **Exhibit A** is a report of all Proofs of Claim ("POCs") filed against CPIC, which have been determined as of January 31, 2023, by the SDR pursuant to TEX. INS. CODE § 443.253. **Exhibit A** identifies the the POC number, the classification of the POC, and the amount allowed (if any), or other action taken on the POC. No timely written objections to the SDR's

determinations of these POCs were submitted under TEX. INS. CODE § 443.253(c) or, if any timely objection was filed, it has been resolved; therefore, the determinations are now final. The SDR submits **Exhibit A** as its First Report of Claims and requests the Court approve its actions on these POCs pursuant to TEX. INS. CODE § 443.258.

3.2 The SDR has not completed the processing of all POCs and anticipates filing one or more additional Reports of Claims in the future.

IV. NOTICE

4.1 Pursuant to TEX. INS. CODE § 443.007(d), this Amended Application has been served on the entire service list for this proceeding, including applicable guaranty associations, in the manner shown on the Certificate of Service.

V. OFFER OF PROOF AND VERIFICATION

5.1 This Amended Application is verified by the affidavit and certification pursuant to TEX. INS. CODE § 443.017(b) of Joseph N. West, designated representative of CANTILO & BENNETT, L.L.P., solely in its capacity as Special Deputy Receiver of Access Insurance Company.

VI. NOTICE OF ELECTRONIC SERVICE REQUIREMENT

6.1 All pleadings filed in response to this Amended Application shall be served by e-mail on the undersigned counsel and all parties shown in the attached Certificate of Service.

PRAYER

WHEREFORE PREMISES CONSIDERED, CANTILO & BENNETT, L.L.P., solely in its capacity as Special Deputy Receiver of Capson Physicians Insurance Company respectfully requests this Court to set a hearing on the Amended Application and upon such hearing,

- a. Grant the Amended Application;
- b. Approve the SDR's First Report of Claims; and
- c. Grant the SDR such further relief to which it is justly entitled.



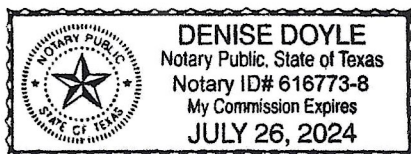



**ORDER GRANTING SPECIAL DEPUTY RECEIVER'S AMENDED APPLICATION
FOR APPROVAL OF FIRST REPORT OF CLAIMS**

On this date, the Court heard the Amended Application for Approval of the SDR's First Report of Claims (the "Application") filed by CANTILO & BENNETT, L.L.P., solely in its capacity as Special Deputy Receiver of Capson Physicians Insurance Company (the "SDR" and "CPIC," respectively). The SDR appeared by and through its counsel.

Having considered the Application, the Court finds as follows:

1. The *Supplemental Order of Reference to Master* provide that motions filed pursuant to TEX. INS. CODE § 443.007 and § 443.258 are referred to the Special Master appointed in this proceeding;
 2. Notice of the Application was provided in accordance with TEX. INS. CODE §443.007 and the *Supplemental Order of Reference to Master*;
 3. The Texas Property and Casualty Insurance Guaranty Association filed its acknowledgement and waiver;
 4. No objections to the Application were filed;
 5. The Court has jurisdiction over the Application and the parties affected hereunder;
- and
6. The SDR's Application should be granted in all respects.
